## FULL, FINAL AND COMPLETE RELEASE

KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the extension to me of the right and privileges of the shooting sports, including the use of handguns, shotguns, rifles and archery, or engaging in any other recreational activities on the property owned by Old Fort Gun Club, Inc. (OFGC), the receipt and sufficiency of which is hereby acknowledged, I, for myself, my heirs and my assigns, do by these presents, fully, finally and completely release and forever discharge OFGC, its officers, directors, agents, employees, and assigns, from any and all claims, demands, actions, causes of actions, liabilities, damages or judgments, directly or indirectly arising from or related to the exercise of the rights granted to me hereunder, irrespective of negligence on the part of any party, including, but not limited to, OFGC. Further, I hereby expressly represent to OFGC that I fully understand and appreciate the risks attendant to the shooting sports with firearms and archery, or engaging in any other recreational activities on the afore-mentioned premises, including, but not limited to, the risk of injury or death from firearms, from animals, domestic and wild, from road and land conditions which may be apparent or hidden. Having a full understanding and appreciation of such risks, I nevertheless voluntarily undertake to enter upon the said premises, and voluntarily encounter such risks at my peril.

I further agree to save and forever hold OFGC harmless from any claim or demand, liability, action, judgment, cost or expense for medical care or treatment, attorney's fees or the like, whether the same asserted by me individually, by assignment, by subrogation, by my heirs or assigns or otherwise.

I further represent and warrant that in executing this release, no representations or promises of any kind have been made to me by OFGC or by anyone on their behalf as an inducement for the release and indemnity, other than the right and privileged of the shooting sports with firearms and archery or engaging in any other recreational activities on the premises of the property owned by OFGC with respect to any dates and times during which I may exercise the rights granted hereunder.

I further represent and warrant that if I am accompanied by a minor on the premises of OFGC, for any reason, the provisions of this Release shall extend to said minor, and I further represent that I am the parent or legal guardian of said minor, or have the consent of the parent or legal guardian of said minor to bring the minor to these premises and to execute this Release.

## OLD FORT GUN CLUB RANGE RULES

### \*\*\*\*SAFETY FIRST\*\*\*\*

1. Use of alcohol and drugs prohibited. Don't do it!
2. All firearms transported to and from the range must be in a safe and unloaded condition. Licensed concealed firearm holders may carry, on their person, a loaded firearm in a concealed manner, except if the person is participating in a sporting event. If the holder intends to fire the firearm it must be unloaded prior to entry to the range.
3. When the firing line is made "safe", all guns must be made safe - - - (unloaded, actions open, pointed down range, and placed on racks or in appropriate cases).
4. Remain behind the firing line while any firearm is being fired or handled by another. Do not handle firearms if someone is down range!
5. Everyone at the range is responsible for safety. If you see someone acting in an unsafe manner, call a halt to the shooting and caution the person.
6. Children and juniors under 18 years old are not allowed on the firing line without direct adult supervision. Safety glasses and hearing protection are required. Small children must be supervised at all times.

### \*\*\*\*GENERAL\*\*\*\*

1. Membership card/badge must be attached to your clothing at all times while on the range. No exceptions -- no badge = no shoot! All members are required to enforce this rule.
2. Guests? Members may bring a local guest to range one time only. They are then required to join to enjoy the benefits of the club. No restriction on out-of-town guests over 50 miles. Members may bring visitors, age 17 and under, to the range with no more than two minors on the firing line per adult supervisor.
3. Approved targets: (Do not shoot cans or bottles)
  - a) Paper targets attached to target frame centers (Don't put targets on frame posts or shoot posts)
  - b) Approved metal silhouette targets and stands
  - c) Shotgun clay targets
  - d) No incendiary ammunition, tracer rounds, exploding targets or fireworks allowed on range(s)

**Note:** Do not shoot at anything on the ground, as dangerous ricochets will occur. Targets must be arranged so rounds impact into a berm when shooting at targets while standing. Do not attach targets to or shoot at the metal silhouette stands. These are for scheduled matches only.

4. Trash cans are for burnable items only. Take all other items home with you for proper disposal. Police the area and leave it cleaner and neater than you found it. Practice courtesy.
5. Range gates and doors should be locked at all times except during scheduled events. Never leave the gate open when you leave unless 100% sure someone else will do it. Never leave the lock hanging with the combination showing. "Spin the dials ---protect your combination"
6. This is a private club for dues paying members only. Nonmembers are welcome to scheduled events.
7. All members must have a current membership to the National Rifle Association and report that information to the club secretary.
8. Violation of these rules is grounds for revocation of membership.
